19 members in the first year class -14 moved up -5 need to do summer baseball umpires are working the same position and need to be assigned both plate and base No JV Tournament – a survey of participants will be developed by Jim and Kevin 13 applicants are already signed for next year

Lee Champagne stressed the need for the North Country to have clinic and suggested that Rick Force would be available to help instruct. Levesque and Witham also made themselves available if needed.

Performance Coordinator: Don Micucci

Some evaluations were completed this season Jim Fletcher did 3 and Don Micucci did 7. - There was some difficulty with the NHIAA membership for two other evaluators Jim Hale and Alan Gorowicz and the NHBUA will pay the NHIAA fee for non members (see New Business)—However it is believed that Alan will soon be a NHBUA member. Don Micucci needs to be informed about any transfers as he needs to evaluate them...... Brian Troupe raised the issue of an increase in evaluators pay. Motion to increase the pay for evaluators (NHIAA) fee moved Rozumek second Welch was unanimously accepted. Supervisor will take to the NHIAA meeting.
